BE IT RESOLVED, by the Council of The City of San Diego as follows:


That the expenditure of \$3,000 from Capital Outlay Fund 245 Reserve of The City of San Diego, be and it is hereby authorized, solely and exclusively, for the purpose of covering the overexpenditure on the RESTORATION OF CALIFORNIA BUILDING, and supplementing Resolution No. 214214 in this amount.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to do by City forces all necessary work in conjunction with the above referenced project by picking up, restoring, reassembling and delivering the wrought iron weather vane which is to be mounted above the California Building Tower, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract, at an estimated cost of \$1,988.67.

BE IT FURTHER RESOLVED, that the expenditure of \$3.75 from Capital Outlay Fund 245 Reserve of The City of San Diego, be and it is hereby authorized, solely and exclusively, for the purpose of covering the overexpenditure for the PUMPS IN COMMUNITY CONCOURSE COOLING SYSTEM project, and supplementing Resolution No. 212414 in this amount.
