WHEREAS, The City of San Diego is the owner of those portions of Section 11, 26 and 27, Township 12 South, Range 1 East, S.B.B.M.; and

WHEREAS, the United States Department of Agriculture, Forest Service, United States of America, has requested the conveyance of easements for the purpose of reconstructing, maintenance, and full, free and quiet use and enjoyment of the existing road as it is located and in place over and across the above described property; and

WHEREAS, the purpose for which the easements are required are public purposes; and

WHEREAS, Section 22.0907 of the San Diego Municipal Code authorizes the conveyance of City property to public agencies for public purposes without complying with the provisions relating to the advertising for bids and auction sales contained in the Municipal Code; and

WHEREAS, the City Manager, pursuant to Section 22.0907 of the San Diego Municipal Code, has recommended that said easements be conveyed to the United States Department of Agriculture, Forest Service, United States of America; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That in consideration of the benefits to accrue to the people of said City, the Mayor and City Clerk of said City be, and

they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, those deeds conveying to the UNITED STATES DEPARTMENT OF AGRICULTURE, FOREST SERVICE, UNITED STATES OF AMERICA, those easements for the reconstructing, maintenance and full, free and quiet use and enjoyment of the existing road as it is located and in place over and across the property, as more particularly described in those forms of Easement Deed for Road, on file in the office of the City Clerk as Documents Nos. 760687, 760688, and 760689.

2. That the City Clerk is hereby authorized and directed to deliver said deeds and a certified copy of this resolution to the Property Director for further handling.
