WHEREAS, the Public Services and Safety Committee, on June 30, 1977, considered a request from Mr. Manual Rios, Director of Casa de Servicios, for financial assistance in the purchase of 70 folding chairs for use by the Club Barrios, a senior citizens' social group; and

WHEREAS, Casa de Servicios is funded through County revenue sharing as a program to provide supportive services for senior citizens social activities; and

WHEREAS, the Public Services and Safety Committee approved said request and recommended that the sum of \$430.50 be allocated from the Fiscal Year 1978 Human Care Services allocation for the purpose of providing funds to enable Casa de Servicios to purchase the requested 70 chairs; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby fully authorized to execute a letter agreement with the Casa de Servicios for and on behalf of The City of San Diego for the purchase of 70 folding chairs to be used in the Club Barrios, as set forth in the letter agreement attached hereto as Attachment A.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to allocate the sum of \$430.50 from the Fiscal Year 1978 federal revenue sharing appropriation to be used solely and exclusively for the above purpose.
