WHEREAS, the California Coastal Act of 1976 states that local governments may submit local coastal programs in separate geographic units; and

WHEREAS, the City of San Diego has tremendous variety in its 21 miles of coastline; and

WHEREAS, the physiographic diversity and distinct communities in the City of San Diego are not amenable to a single plan; and

WHEREAS, the City of San Diego's Planning Department has recommended that local coastal planning programs be achieved by separate submission of community plans; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that The City of San Diego hereby expresses its intent to submit its Local Coastal Planning Programs in separate geographic units and requests that the California Coastal Commission permit its filing pursuant to Public Resources Code Section 30511(c).
