RESOLUTION OF INTENTION TO DECLARE TRAVELED
WAY IN SECTION 30, TOWNSHIP 13 SOUTH, RANGE
2 WEST AND SECTION 25, TOWNSHIP 13 SOUTH,
RANGE 3 WEST (OS 124) TO BE A PUBLIC ROAD.

WHEREAS, the Council has received a petition prepared
by E. Ludlow Kenney on behalf of certain property owners to
declare Old Survey (OS) 124 within Section 30, Township 13
South, Range 2 West and Section 25, Township 13 South, Range
3 West to be a public road; and

WHEREAS, it is alleged that a traveled way generally
following OS 124 has been used by the public continuously
for more than five years; and

WHEREAS, such use does not appear to have been subject
to any objection by any property owner over which the
traveled way runs; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego
as follows:

1. The City Clerk is hereby directed to schedule a
hearing at a future Council meeting for the purpose of
determining whether or not that traveled way in the City of
San Diego generally following OS 124 along the northerly
boundary of Section 30, Township 13 South, Range 2 West and
Section 25, Township 13 South, Range 3 West is a public
road.

2. The City Clerk shall give mailed notice of said
hearing 10 days prior thereto to all owners of property
across which said traveled way runs as said owners are

shown on the latest records in the office of the County Assessor.


3. The City Clerk shall also publish notice of said hearing at least once ten (10) days prior thereto in a newspaper of general circulation in the City of San Diego.

4. The Director of Engineering and Development is directed to give such assistance as the City Clerk may need in ascertaining the owners of the property involved and such other assistance as may be necessary.

5. Prior to mailing and publication of notice, petitioner shall pay to the City Clerk the cost thereof.
