HAZARD CONTRACTING CO., a corporation, for the IMPROVEMENTS IN TORREY PINES SCIENCE PARK UNIT NO. 2, including Addenda A and B, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 759612.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, utility service agreements with San Diego Gas & Electric Co. and Pacific Telephone & Telegraph Co., pursuant to the terms and conditions of the form of agreements on file in the office of the City Clerk as Documents Nos. 760471 and 760472.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to expend the sum of \$656,730.00 out of the Land Development Trust Fund (Fund 314) of The City of San Diego to be used solely and exclusively for the purpose of providing funds for the above improvements and agreements and related costs.
