

RESOLUTION NO. 215980

(R. 78-68) AUG 3 1977

WHEREAS, there were relinquished to The City of San Diego certain abutter's rights of access in and to Gilman Drive from Lot 1, Harrington Hollow, according to Map No. 3683, on file in the San Diego County Recorder's Office; and

WHEREAS, the Engineering and Development Department has requested that the City revest a portion of said abutter's rights of access in the property to TEMPLE BETH EL, INC., a California corporation, the owner of said property, to provide access to the easterly side of the parcel; and

WHEREAS, said abutter's rights of access are no longer needed by the City and should be revested in the property; and

WHEREAS, it has been determined that all affected City departments have no objection to the revestment of said abutter's rights; and

WHEREAS, a fee of sixty-five dollars (\$65) has been received as the negotiated value of said rights; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; and

WHEREAS, the City Manager recommends that said access rights be revested in the property; NOW, THEREFORE,
