

POLK AVENUE

All that portion of the Alley in Block 2, Chester Park Addition, according to Map thereof No. 1354, filed in the San Diego Office of the County Recorder, State of California, more particularly described as follows:

Commencing at the intersection of the northerly line of Polk Avenue, as located and established by Deed to the City of San Diego, filed in the Office of the San Diego County Recorder at File/Page No. 77-144262 on April 19, 1977 with the Easterly line of Menlo Avenue, as located and established as of the date of this instrument; thence along said northerly line, North 89°59'28" East to an intersection with the westerly line of said Alley in Block 2, Chester Park Addition, being also the TRUE POINT OF BEGINNING; thence continuing North 89°59'28" East, 20.00 feet to the easterly line of said alley; thence along said easterly line, South 00°02'02" East, 16.00 feet; thence leaving said Easterly line, South 89°59'28" West, 20.00 feet, returning to the said westerly line of the alley; thence along said westerly line, North 00°02'02" West, 16.00 feet, returning to the TRUE POINT OF BEGINNING.

Basis of Bearings is the centerline of Euclid Avenue, assumed north.
