- 2. That the City Auditor and Comptroller is hereby authorized to transfer \$672,000 within Sewer Revenue Fund 506 from Unallocated Reserve 69.97 to CIP 43-028, and that expenditure of said funds is hereby authorized, solely and exclusively for the

3.
