BE IT RESOLVED, by the Council of The City of San Diego as follows:

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby authorized and empowered, for and on behalf of said City, to negotiate and execute agreements with two (2) community or governmental agencies (San Diego Unified School District - Senior Citizens Nutrition Program; San Diego State University Foundation, Inc. - Bridges to Business) to operate social service programs for a ten-month (10-month) period from September 1, 1977, through June 30, 1978, and one (1) community agency (Model Ex-Offenders of San Diego County, Inc. - Rehabilitation of Ex-Offenders) for a four-month (4-month) period from September 1, 1977 through December 31, 1977, and to commit \$146,380 in Fiscal Year '78 Facilities Reserve Funds.

BE IT FURTHER RESOLVED, that the expenditure of \$24,000 is hereby authorized out of Fiscal Year '78 Facilities Reserve Funds for the operation of Job Training and Placement Services for Physically Disabled by the Housing and Community Services Department for a ten-month (10-month) period from September 1, 1977 through June 30, 1978.
