WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

| <u>NAME</u> | <u>DEPARTMENT</u> | <u>AMOUNT</u> | <u>SUGGESTION</u> |
|-------------------|---------------------|---------------|--|
| Norman V. Newton | Police | \$ 85 | One year ago Officer Newton suggested that handouts for Spanish-speaking motorists be provided to patrol officers. His idea saved a total of \$1,708 in the first year of operation, and this is the remainder of his award. |
| Ted E. Suter | Police | \$ 55 | Officer Suter suggested that the second copy of the Hit and Run Report be retained by the follow-up investigator until the case is cancelled. This saves \$543 per year in the Records Section. |
| Julian A. Johnson | Employee Services | \$ 40 | Mr. Johnson is a Claims Representative. He suggested that the Police Department send only one copy of Police and fire accident reports to the Claims Division. This saves approximately \$ 400 per year in copying costs. |
| Ted E. Suter | Police | \$ 30 | One year ago Officer Suter suggested a revision to the Hit and Run Report. Total savings for his idea came to \$2,082. This is the remainder of his award. |
| Carol Harrison | Employee Services | \$ 20 | One year ago Ms. Harrison devised a form memorandum to be used in the updating of suggestions. Total first year savings came to \$407. This is the remainder of her award. |
| Glenn S. Peden | Building Inspection | \$ 20 | One year ago Mr. Peden suggested that business licenses and/or housing permits be printed in post card form. The total first year savings amounted to \$1,480. This is the remainder of his award. |
