WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Valdimir Kisak	Park and Recreation	\$ 15	Mr. Kisak is a Recreation Facility Caretaker in the Recreation Division. He suggested that concrete enclosures be installed for base anchor spikes. This saves approximately \$150 per year.
William L. Matthews	Water Utilities	\$ 10	Mr. Matthews is a Waste Water Plant Operator in Water Utilities. He suggested that pull handles be installed on the belt guards of sludge pumps. This was felt to be a significant safety improvement.
Robert D. Peters	Engineering and Development	\$ 10	Mr. Peters is a Senior Engineering Aide. He suggested that a form be replaced with a rubber stamp when mailing out multiple building permit plan checks. This saves about \$100 per year in printing costs.
Margaret A. McLaughlin	Treasurer's Office	\$ 10	Ms. McLaughlin is a Senior Stenographer. She devised a form letter to be used in the Deferred Compensation area. The use of the form letter saves approximately \$100 per year in typing time.
