APPROVING MAP OF TREPTE INDUSTRIAL PARK UNIT  
NO. 1.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed  
by CHARLES W. CHRISTENSEN, a Registered Civil Engineer, entitled  
"TREPTE INDUSTRIAL PARK UNIT NO. 1 Being a subdivision of  
the North Half of the Northeast Quarter of the Northeast  
Quarter of Section 11, Township 15 South, Range 3 West,  
San Bernardino Meridian, in the City of San Diego, County  
of San Diego, State of California, according to Official  
Plat thereof.", is made in the manner and form prescribed  
by law and conforms to the surrounding surveys; that said  
map and the subdivision of land shown thereon is hereby  
approved and accepted; and said Council hereby accepts on  
behalf of the public, the following: a portion of Trade  
Street for public purposes, and said portion of a street  
is hereby declared to be a public street and dedicated to  
the public use.

BE IT FURTHER RESOLVED, that said Council hereby rejects  
as a dedication that portion of Lot 3, marked "Reserved for  
Future Street," as shown on this map, under the provisions  
of Section 66440 of the Government Code.

BE IT FURTHER RESOLVED, that said Council hereby accepts  
on behalf of The City of San Diego, a municipal corporation,  
the easement with the the right of ingress and egress for  
the construction and maintenance of drainage facilities as  
granted and shown on said map and subject to the conditions  
set forth thereon.
