BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, a Registered Civil Engineer, entitled "SAN DIEGO CENTER UNIT NO. 4 Being a subdivision of the Northwest Quarter of the Northwest Quarter of the Southwest Quarter of the Southeast Quarter of Section 1, Township 14 South, Range 4 West, in the City of San Diego, County of San Diego, State of California, except therefrom that portion lying south of the San Dieguito Highway as said road existed on March 25, 1957.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: a portion of Via De La Valle, for public purposes, and said portion of a street is hereby declared to be a portion of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement for open space over, under, upon, and across a portion of Lot 5, as granted and shown on said map and subject to the conditions set forth thereon.
