MILLER, husband and wife as joint tenants, as to an undivided one-half interest and SAN DIEGO TRUST AND SAVINGS BANK as Trustee, pursuant to Trust Agreement No. 1-2542-00-6, as to an undivided one-half interest, granting to said City, all that real property across that portion of that certain parcel of land delineated and designated as "Reservoir" in Del Mar Heights; and Lots 4, 5, and 6 in Block 16 of Del Mar Heights, all as more particularly described in said form of Grant Deed, for the Park District No. 10 Crest Canyon Project.

That the City Clerk is hereby authorized and directed to deliver said deed along with certified copies of this resolution to the Property Director for further handling.
