as follows:

By making the following changes to existing contracts:

1. Amending regular tow truck service from \$18.50 regular
tow to \$23 per vehicle, first hour.
2. Amending from \$21 per accident tow to \$26 per vehicle,
first hour.
3. One and one-half hour tow rate from \$27.25 to \$34.50 per
vehicle for the first hour.
4. Heavy duty tow rate from \$35 to \$45 an hour.


5. Storage - from 25¢ an hour for first 12 hours, to 50¢ an hour for first eight hours. From maximum of \$3 a day to a maximum of \$4 a day.

6. Labor at scene regular truck and operator from \$15 an hour to \$5 per one-quarter hour or part thereof.

7. Booms in lieu of twin booms - truck may contain single boom with two winches controlling separate boom lines.
