That the bid of Morton Equipment & Supply Co. is hereby accepted and the City Manager is hereby authorized to execute a contract for the RENTAL OF A MINIMUM OF 3,000 PORTABLE FREE-STANDING GRANDSTAND BLEACHER SEATS AND TWO (2) PORTABLE EXIT STAIRWAYS for a six (6) month period beginning August 1, 1977 through January 31, 1978 at a cost of \$19,400.00 for the six month period; terms net, with options to renew for three (3) additional six (6) month periods at the same price and terms subject to an escalation not to exceed 9% of the bid price.
