

WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where the street to be vacated has been superseded by relocation; and

WHEREAS, PLACER STREET adjacent to lot 93 of Wheatley Hills has been relocated by the approval on this date of the dedication of the right of way for Genesee Avenue by the acceptance of the final map of the subdivision to be known as PARK MESA; and

WHEREAS, those properties adjoining the portion of PLACER STREET to be vacated will continue to have access or will be accessible by the street which has been dedicated with the approval on this date of the subdivision to be known as PARK MESA: NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That PLACER STREET adjacent to lot 93, Wheatley Hills, as more particularly shown on Drawing No. 13788-B, on file in the office of the City Clerk as Document No. 760655, which is by this reference incorporated herein and made a part hereof, be and the same is hereby vacated.

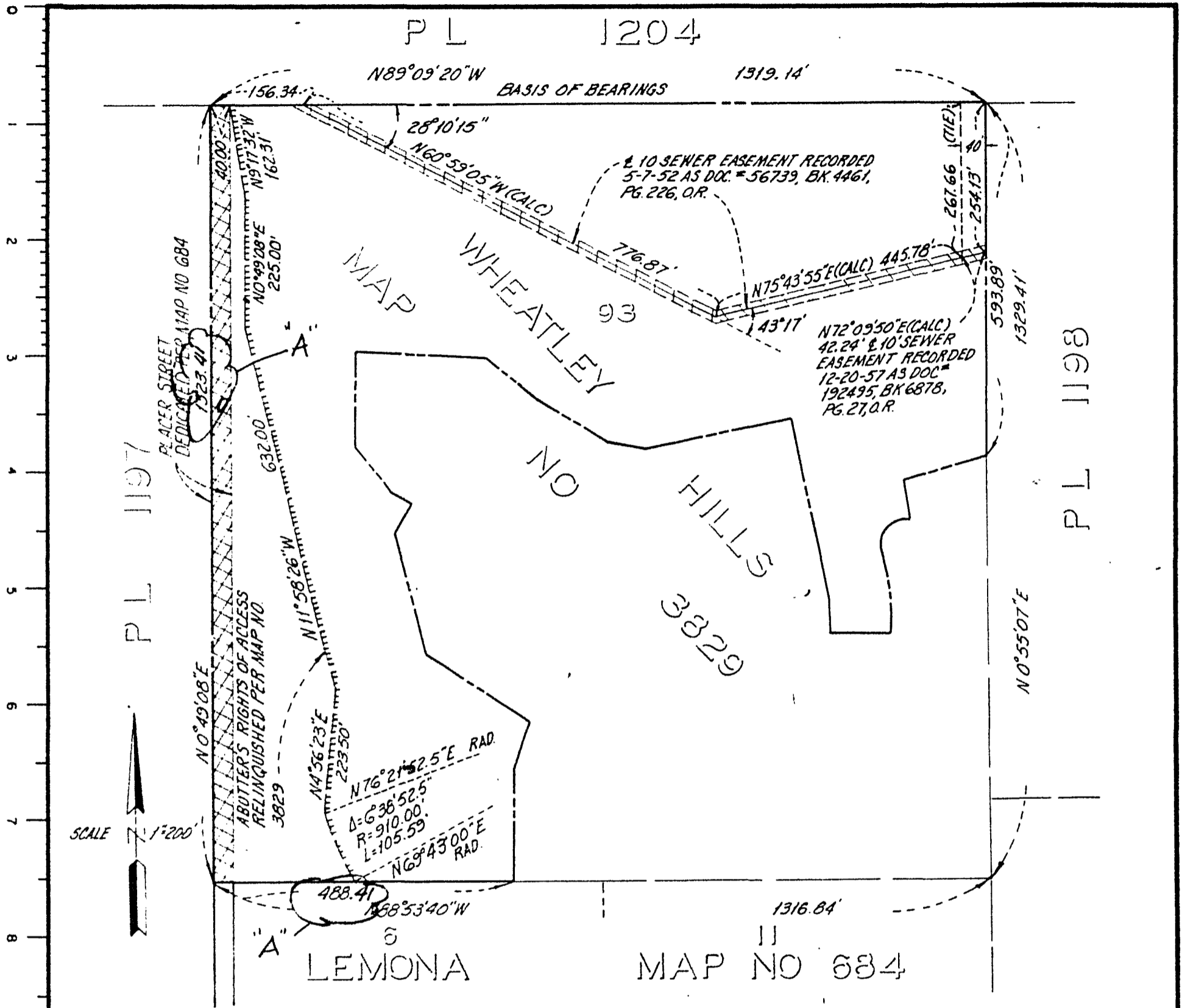
2. That the City Clerk shall cause a certified copy of this resolution with drawing, attested by him under seal, to be recorded in the office of the San Diego County Recorder.




BASIS OF BEARINGS

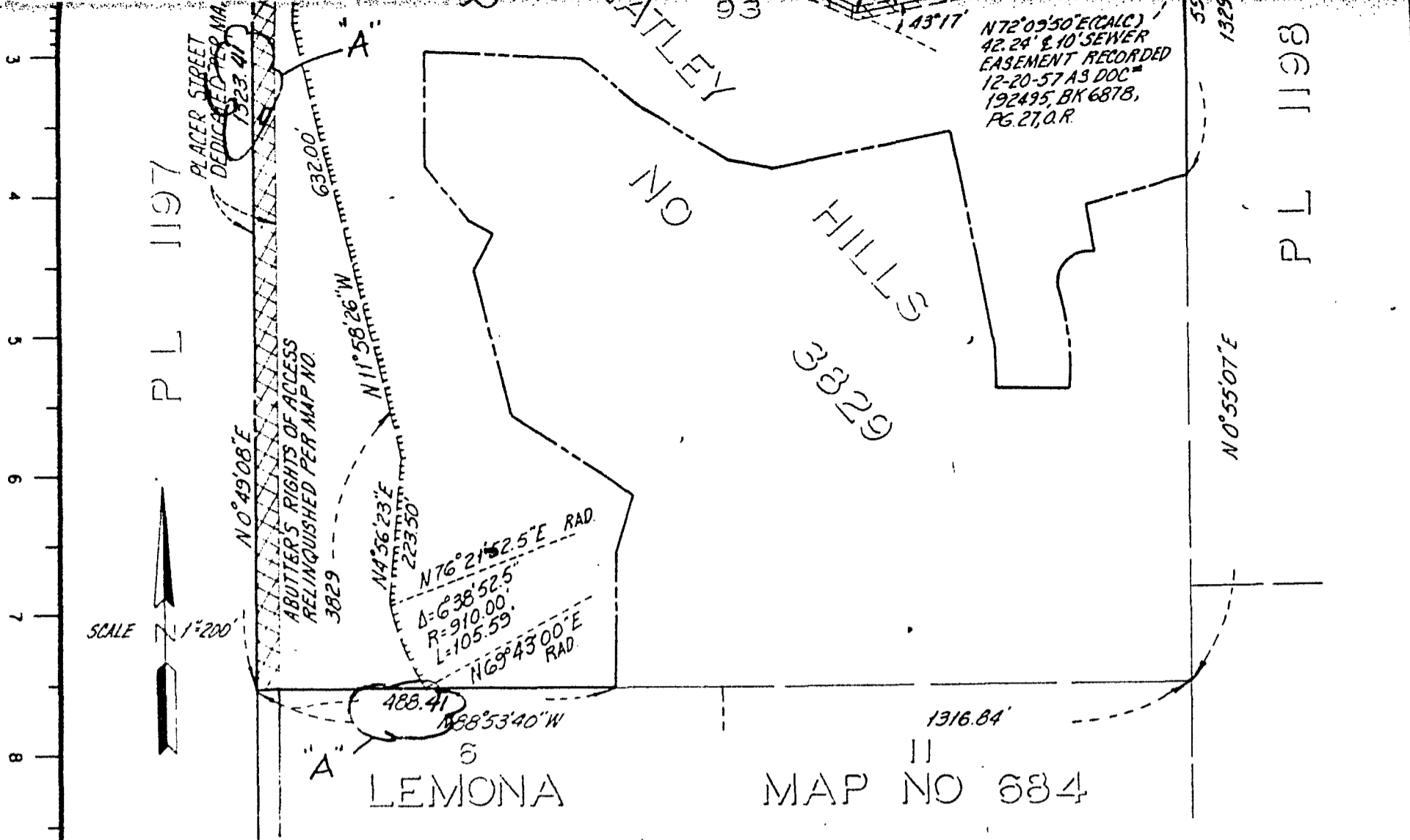
