APPROVING MAP OF RANCHO JARANA UNIT NO. 4 SUBDIVISION
AND ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S ASSURANCE
OF COMPLIANCE WITH THE AFFIRMATIVE MARKETING PROGRAM.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by W. R. NOTHOMB, a Licensed Land Surveyor, entitled "RANCHO
JARANA UNIT NO. 4 Being a subdivision of the Northwest Quarter
of the Southwest Quarter of the Northwest Quarter of Section 35,
Township 18 South, Range 2 West, San Bernardino Meridian, in the
City of San Diego, County of San Diego, State of California.",
is made in the manner and form prescribed by law and conforms
to the surrounding surveys; that said map and the subdivision
of land shown thereon is hereby approved and accepted; and
said Council hereby accepts on behalf of the public, the
following: Howard Avenue, Lonja Way, Meadowood Court, and a
portion of Don Pancho Way for public purposes; and said streets
and portion of a street are hereby declared to be public streets
and portion of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts
on behalf of The City of San Diego, a municipal corporation,
any and all abutters' rights of access in and to Lonja Way,
adjacent and contiguous to Lot 332, all as shown on this map
within this subdivision and subject to the conditions set
forth thereon.

to endorse upon said map, as and for the act of the Council,
