WHEREAS, the Sweet Adelines, Inc. has booked the Fox Theatre for its convention on March 10 and 11, 1978; and

WHEREAS, in the past, the Civic Theatre has been used for this annual event; and

WHEREAS, due to heavy usage of the Civic Theatre, the specified dates were not available to the group; and

WHEREAS, the Sweet Adelines chose to book its convention in the Fox Theatre rather than move to another city; and

WHEREAS, the Sweet Adelines have previously qualified and presently qualifies as an approved convention, the rental charges for which are paid from Transient Occupancy Tax funds designated for sponsored conventions; and

WHEREAS, the Sweet Adelines, as an approved convention, are now requesting that the rental charges for the Fox Theatre be borne by the Transient Occupancy Tax funds designated for that purpose; and

WHEREAS, funding is available for the Civic Theatre under the Council allocated budgetary authorization; and

WHEREAS, the Fox Theatre is being used as an alternate site due to unavailability of the Civic Theatre and the same funding concept should apply; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the booking of the Fox Theatre for an approved convention to be held by the Sweet Adelines, Inc. on March 10 and 11, 1978, be and the same is hereby approved as acceptable for sponsored convention funding by the City.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to expend the sum of \$1,500 from the Transient Occupancy Tax Fund 223, Contingency Reserve (52.29) solely and exclusively for the purpose of reimbursing the Sweet Adelines, Inc. for the cost of renting the Fox Theatre on March 10 and 11, 1978 for their national convention.
