

RESOLUTION NO. 219087

WHEREAS, the La Jolla Parking Committee has submitted a report which, among other things, recommends that the City Council proceed with the formation of a "Parking and Business Improvement Area" in the central area of La Jolla under the Parking and Business Improvement Area Law of 1965 (Streets and Highways Code Sections 36000-36081); and

WHEREAS, the Council is also requested to appoint an advisory board to make recommendations with respect to acquisition, construction and maintenance of parking facilities and the promotion of retail trade activities; and

WHEREAS, prior to the formation of said parking area and advisory board, it is necessary that a temporary committee representing various La Jolla business interests be formed under Section 43(b) of the Charter for the purpose of making certain recommendations as hereinafter enumerated; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. The City Council does hereby accept the La Jolla Parking Committee Report dated April 19, 1977.
2. The City Manager is hereby directed to take the necessary actions to bring about the Resolution of Intention hearing for establishment of the proposed "Parking and Business Improvement Area" in the central area of La Jolla under the provisions


of the Parking and Business Improvement Area Law of 1965
(Streets and Highways Code Section 36000-36081).

3. The City Manager is hereby directed to reimburse the City 100 Fund for City expense if and when the said "Parking and Business Improvement Area" becomes law.

4. The Mayor is hereby requested to appoint a temporary seven-member committee subject to City Council confirmation under Section 43(b) of the Charter that would represent various interests in the La Jolla Business District for the purpose of making recommendations on the following:

- (a) A precise description of the boundaries of the proposed area;
- (b) The proposed uses to which the collected fees would be put; and
- (c) The additional levy of the license tax required to support the activities of the District.
