WHEREAS, the Office of Criminal Justice Planning (hereinafter referred to as OCJP) has agreed to partially fund the project submitted by The City of San Diego referred to as "Neighborhood Crime Prevention" from funds made available through the Omnibus Crime Control and Safe Streets Act of 1968, Public Law 90-351 (hereinafter referred to as the Crime Control Act); NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be, and he is hereby authorized to execute and submit, for and on behalf of said City, to OCJP the application/grant award for law enforcement purposes, including any extension or amendments thereof, that do not require any additional appropriation of cash match.

2. That The City of San Diego agrees to provide the required matching funds for said project (including any extension or amendments thereof) under the Crime Control Act and the rules and regulations of OCJP and the Law Enforcement Administration.

3. That grant funds received hereunder shall not be used to supplant ongoing law enforcement expenditures.

4. That the City Manager is authorized without further Council action to go to bid (when necessary) and to execute contracts for the consultant services, leases, purchases, and all other related contracts and agreements specified in the grant contract.

5. That \$7,290 of City funds shall be appropriated in the City's Fiscal Year 1977-78 Budget for the purpose of the required cash match specified in the grant contract and that said funds are hereby authorized to be expended pursuant to the terms of the grant contract.
