WHEREAS, there is continued precedent in the San Diego area of communities of unique identity characteristics to retain postal service under the communities' historical names; and

WHEREAS, San Ysidro is separated from the City of San Diego core area by the Cities of Imperial Beach, Chula Vista and National City; and

WHEREAS, it is necessary for the economic well being and sustenance of trade that communities have a continuity of identity and sustained promotional efforts; and

WHEREAS, there is a repetition of street names between San Diego and San Ysidro; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:
