

RESOLUTION NO. 219100

WHEREAS, Resolution No. 218771, adopted June 29, 1977, approving a lease agreement with Witman Ranch, Inc., was rescinded by Resolution No. 219045, adopted August 10, 1977; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That in place of said agreement the City Manager is hereby authorized and empowered to execute a substitute lease agreement with WITMAN RANCH, INC., for the purposes of a rotational agricultural program of mixed row and foreage crops integrated with cattle grazing on native growth and residue and for such other related or incidental purposes as may first be approved in writing by the City and for no other purposes, for a term of 15 years, under the terms and conditions set forth in said form of lease agreement on file in the office of the City Clerk as Document No. 761147.

2. That this resolution shall take effect upon the effective date of Ordinance No. 12111, (New Series), entitled Waiving Provisions of Municipal Code Section 22.0901 With Regard to the Requirements of Independent Fee Appraisals, and 30 Day filing period with the City Clerk's Office, with regard to the San Pasqual Agricultural Leases.
