BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of JOSEPH BELLO, an unmarried man, executed in favor of The City of San Diego, bearing date of February 28, 1977, conveying to said City the permanent easement and right-of-way for a public alley and incidents thereto, over, under, upon, along and across all that portion of Lots 15, 16, 17, 18, 19, 20, 21 and 22 of Block 118, according to Morena Map No. 809, filed in the office of the San Diego County Recorder, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for an alley.

That the City Clerk is hereby authorized and directed to file said deed after acceptance by the City Manager, along with certified copies of this resolution for record in the office of the San Diego County Recorder.
