

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those deeds of WILLIAM L. WORKMAN and BARBARA J. WORKMAN, husband and wife; and ROBERT L. THOMPSON and BARBARA JOAN THOMPSON, husband and wife, executed in favor of The City of San Diego, bearing dates of June 2, 1977 and June 3, 1977, conveying to said City the permanent easement and right-of-way for a public alley and incidents thereto, over, under, upon, along and across all that portion of Lots 23, 24, 25 and 26 of Block 118, according to Morena Map No. 809, filed in the office of the San Diego County Recorder, as more particularly described in said deeds, be, and the same is hereby approved and the land therein described is hereby dedicated as and for a public alley.
