as follows:

Said Council hereby finds that that certain map surveyed by RALPH E. BOLLES, a Registered Civil Engineer, entitled "LONGFORD CANYON ESTATES Being a subdivision of Parcel 1 in the City of San Diego, County of San Diego, State of California as shown at Page 485 of Parcel Maps filed in the office of the County Recorder of San Diego County, March 30, 1971." is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Longford Place[✓], for public purposes; and said street is hereby declared to be a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street is accepted on behalf of the public as
