APPROVING MAP OF MOUNT SOLEDAD SOUTH

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by RONALD D. HOGAN, a Registered Civil Engineer, entitled "MOUNT SOLEDAD SOUTH Being a subdivision of the Northeast Quarter of Pueblo Lot 1255 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, filed in the office of the County Recorder of San Diego County on November 14, 1921 and is known as Miscellaneous Map No. 36, together with a portion of La Jolla Scenic Drive South as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of La Jolla Scenic Drive South for public purposes; and said portion of a street is hereby declared to be a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of water facilities as granted and shown on said map and subject to the conditions set forth thereon.
