RESOLUTION NO. 219131

(R. 78-229)

WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where those streets to be vacated have been superseded by relocation; and

WHEREAS, BEYER WAY and ROAD SURVEY 294 have been relocated by the approval on this date of the dedication of new rights of way by the acceptance of the final map of the subdivision to be known as OLYMPIC PARK UNIT NO. 2; and

WHEREAS, those properties adjoining the streets to be vacated will continue to have access or will be accessible by the streets which have been dedicated with the approval on this date of the subdivision to be known as OLYMPIC PARK UNIT NO. 2; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That BEYER WAY and ROAD SURVEY 294 as more particularly shown on Drawing No. 13965-B on file in the office of the City Clerk as Document No. 760826, which is by this reference incorporated herein and made a part hereof, be, and the same is hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution with drawing, attested by him under seal, to be recorded in the office of the County Recorder.

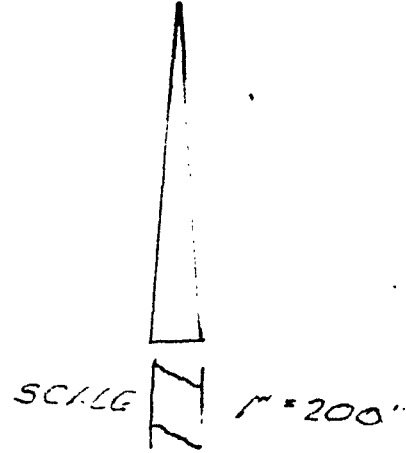

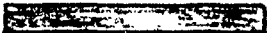
