

RESOLUTION No. 219133 (R-78-223)


Adopted on AUG 24 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the petition for the improvement of LYDIA STREET BETWEEN HOPKINS STREET (IMPROVED PORTION) AND HOPKINS STREET (UNIMPROVED PORTION), under the provisions of the Improvement Act of 1911, consisting of one sheet and filed under Document No. 760813, is hereby granted.

That the City Manager be, and he is hereby directed to prepare plans, drawings, typical cross-sections, profiles and specifications for the improvement of LYDIA STREET BETWEEN HOPKINS STREET (IMPROVED PORTION) AND HOPKINS STREET (UNIMPROVED PORTION), in the City of San Diego, by the grading, paving and the installation of curbs, gutters, sidewalks and water and sewer mains, together with estimates of the costs and expenses of such work and to furnish this Council with a description of the district to be included in the assessment for the work and improvements hereinabove mentioned.
