WHEREAS, the Council of The City of San Diego requested the Transportation and Land Use Committee of said Council to consider the matter of the applications of MISSION CABLE TV, INC. and AMERICAN TELEVISION AND COMMUNICATION CORPORATION to increase the rates for cable television in their respective service areas in the City of San Diego; and

WHEREAS, the Transportation and Land Use Committee has prepared a report of Findings of Fact dated August 9, 1977, a copy of which has been filed with the City Clerk as Document No. 760824; and

WHEREAS, the City Clerk has caused to be served copies of said report upon all parties to the proceeding; and

WHEREAS, all exceptions and replies to exceptions to the report have been duly and fully considered by this City Council;  
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That this Council hereby approves and adopts the Findings of Fact and rates and charges recommended in the August 9, 1977 report of the Transportation and Land Use Committee which is on file in the office of the City Clerk as Document No. 760824, and finds and concludes that the rates and charges set forth in said report are just and reasonable.

BE IT FURTHER RESOLVED, that the Council specifically notes the Finding on page 4 of Document No. 760824



concerning certain deficiencies in the level of service provided by the applicants and the "build-out" schedules referred to therein and affirms that, based on the recommendation of the Transportation and Land Use Committee, it is this Council's intention to consider compliance with these respective build-out schedules in the determination of allowable rates of return in future rate hearings.

BE IT FURTHER RESOLVED, that MISSION CABLE TV and AMERICAN TELEVISION AND COMMUNICATION CORPORATION shall file an advisory letter with the City and notify their respective customers at least 30 days prior to increasing any rates and charges as authorized in this resolution.
