BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to indicate approval for and on behalf of the City of San Diego of six subleases between HIGH FLIERS, LTD., City's lessee of property in the Quivira Basin, Mission Bay Park area, (Document No. 739551) and IONIAN CORPORATION, a California corporation; JUNGRY JOSE/SAN DIEGO, INC., a California corporation, EARL F. TRITT, JR., dba M & E LIQUOR; LLOYD J. JENSEN and EDANNA D. JENSEN; LAWRENCE J. GREENBERG; and FLIERS INCORPORATED, a California corporation, pursuant to which HIGH FLIERS, LTD., subleases portions of its leasehold area under the terms and conditions set forth in the forms of sublease which are on file in the office of the City Clerk as Document Nos. 760848, 760849, 760850, 760851, 760852, and 760853, respectively.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to signify the City's approval of subsequent subleases between HIGH FLIERS, LTD., and sublessees of the leased premises so long as said subleases do not vary in substance from the provisions of the hereinabove identified six initial subleases.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to deliver said documents, along with a certified copy of this resolution to the Property Director for further handling.
