BE IT RESOLVED, by the Council of The City of San Diego that based on the evidence presented and described above that the traveled way generally following Old Survey 124, as shown in red on that map on file in the office of the City Clerk as Document No. 760827, be and it is hereby declared to be a public road in its present location and to the extent of its present width, and no other or further representations or assurances are made hereby.
