WHEREAS, The City of San Diego has worked with the Comprehensive Planning Organization in the preparation of updated population and occupied housing unit forecasts for the City; and

WHEREAS, this cooperative effort was initiated in order to obtain a set of estimates to serve as a basis for regional planning efforts; and

WHEREAS, these forecasts reflect both the Community and General Plan of The City of San Diego and will provide the basis for: (1) The planning of future sewage collection and treatment facilities as a component of the Areawide Water Quality Management Plan being prepared by the Comprehensive Planning Organization with the assistance of local agencies; and (2) The Air Quality Maintenance Plan being prepared by the CPO and the Air Pollution Control District with the assistance of local agencies; and

WHEREAS, local agreement on a consistent set of forecasts will minimize questions about population growth often raised by the federal and state agencies which fund wastewater treatment facilities and hence save time and money for local jurisdictions seeking such funding; and

WHEREAS, this forecast will be revised every two years and/or when a major policy is adopted by a governmental agency having an effect on numbers of people and the distribution pattern; and

WHEREAS, the acceptance of these forecasts will have no effect on the state subventions received by The City of San Diego, NOW, THEREFORE,
