BE IT RESOLVED, by the Council of The City of San Diego as follows:

That pursuant to California Public Resources Code Section 21081, the Council makes the following findings concerning the environmental impacts identified in Environmental Impact Report No. 76-09-23:

The project site has previously been graded and the proposed development will not result in any environmental impacts except those associated with an incremental effect approximating 1 percent of the potential development for the area. The only mitigation possible is the no project alternative which is economically infeasible for the developer and is socially infeasible from the point of view of the community because the housing is badly needed and the area is within the developed urban area.
