WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Louis Denov	Transportation Department	\$ 85	Mr. Denov is an Electronic Technician in the Communications and Electrical Division. He suggested that the van used for mobile repairs be altered by adding a side door. This not only allows greater use of the van, but it also saves \$849 annually in personnel time.
Clifford F. Thomsen	Transportation Department	\$ 50	Mr. Thomsen was an Electrical Foreman in the Communications and Electrical Division. He suggested that the Point Loma Sewage Treatment Plant primary underground be made into a loop circuit. This is to be done shortly. Savings are difficult to estimate but are considered substantial.
Carmen C. Lutes	Engineering and Development Dept.	\$ 40	Ms. Lutes is an Intermediate Stenographer in the Permits Section. She suggested that an alphabetical card catalogue index system be converted to a semi-automated system. Annual savings are estimated at \$397.
Kathleen L. Wyrill	Auditor and Comptroller Dept.	\$ 20	Ms. Wyrill is a Senior Account Clerk. She suggested a revision to the Water Utilities Accounts Receivable procedures. The estimated saving in both time and material is \$183 annually.
