

RESOLUTION NO. 219176Adopted on AUG 31 1977

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Elvin L. Cuff	General Services	\$ 15	Mr. Cuff is an Equipment Mechanic in the Equipment Division. He suggested that seal guards be installed over gutter broom shaft motors on mobile sweepers to prevent foreign materials from grooving the shaft. This is expected to save \$150 annually in repair costs.
Edith B. Eglan	Park and Recreation	\$ 10	Ms. Eglan is an Intermediate Stenographer in the Golf and Lakes Division. She suggested that brochures be mailed without envelopes. This is expected to save the City approximately \$100 a year.
Arthur L. Monett	Water Utilities	\$ 10	Mr. Monett is a Plant Operator II. He suggested that hand operated valves be installed in air control lines. Savings are difficult to estimate.
Kenneth G. Pickle	Fire	\$ 10	Mr. Pickle is a Firefighter. He suggested that zone transmission periods be changed. This was felt to be a significant safety idea.
Linda L. Smith	Employee Services	\$ 10	Ms. Smith is an Intermediate Typist. She suggested that the Suggestion Awards Program send introduction letters to all new employees. This was felt to be a significant program improvement.
