


RESOLUTION No. 219188 (R-78-35 )

Adopted on AUG 31 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those grant deeds of LEADERSHIP HOUSING SYSTEMS, INC., a New York corporation, executed in favor of The City of San Diego, conveying to said City the following properties: (1) Lot 524 of North Miramar Ranch Unit No. 6, Map No. 8003, bearing date of March 9, 1976; (2) Lot 575 of Scripps Ranch Unit No. 7, Map No. 7667, bearing date of March 30, 1976; (3) Lot 473 of Scripps Ranch Unit No. 6, Map No. 7520, bearing date of March 9, 1976; (4) Lot 4 of Scripps Village Center Unit No. 3, Map No. 7085, bearing date of March 30, 1976; (5) Parcel B of Parcel Map No. 917 being a division of Lots 152 and 206 of Scripps Ranch Unit No. 3, Map No. 6655, bearing date of June 2, 1977; (6) Lot 576 of Scripps Ranch Unit No. 7, Map No. 7667, bearing date of March 30, 1976; all for the purpose of providing the City with six open space parcels, all as more particularly described in said deeds, be, and the same are hereby approved.
