
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a first amendment to agreement with BLAYLOCK-WILLIS AND ASSOCIATES, for professional engineering services in connection with the construction and widening of BEYER WAY, between Palm Avenue and the North City Limits, and construction of a new bridge over the OTAY RIVER, in the City of San Diego, under the terms and conditions set forth in the form of first amendment to agreement on file in the office of the City Clerk as Document No. 760896.

BE IT FURTHER RESOLVED, that expenditure of \$15,000 is hereby authorized out of Gas Tax Fund 220 of The City of San Diego, solely and exclusively for the purpose of providing funds for the above-referenced services.
