BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute for, and on behalf of said City, an agreement with the YOUNG WOMEN'S CHRISTIAN ASSOCIATION OF SAN DIEGO, INC., to administer the Edwards Cultural Arts Project, a revenue sharing program, for a five (5) month period, from September 1, 1977 through January 31, 1978, and to commit \$25,000 of Fiscal Year 1978 Revenue Sharing Funds for this purpose, under terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 760925.
