
Adopted on AUG 31 1977

BE IT FURTHER RESOLVED, that the expenditure of \$94,300 is hereby authorized out of Community Development Block Grant Fund 2930 of The City of San Diego, solely and exclusively for the purpose of providing funds for the above-referenced services.
