BE IT RESOLVED, by the Council of The City of San Diego that the Linda Vista Community Planning Organization is directed to amend Article VI, Section 2 of its Charter to delete the provisions specifying that the Electors shall advise on major plans, concepts, or positions, or any other policy positions which might arise.

BE IT FURTHER RESOLVED, that the failure of the Linda Vista Community Planning Organization to so amend its Charter shall result in the City withdrawing official recognition of the Linda Vista Community Planning Organization as the citizen group authorized to work with City staff in the development, amendment, and implementation of a community plan for the Linda Vista area due to nonconformance with Council Policy 600-24.
