WHEREAS, the San Diego & Arizona Eastern Railway Company (SD&AE) on August 9, 1977, filed an application with the Interstate Commerce Commission for permission to abandon that portion of their lines west of Plaster City; and

WHEREAS, said abandonment will terminate direct railway service between San Diego and the Imperial Valley, Arizona and points east; and

WHEREAS, such abandonment will undoubtedly result in increasing the cost for transporting goods between San Diego and said points and increasing the use of trucks with attendant adverse environmental consequences; and

WHEREAS, the SD&AE line is one of only two serving this area with a population of over a million on the United States side of the International Border and approaching half a million on the Mexican side; and

WHEREAS, the abandonment will virtually throw away millions of dollars spent on the construction of the line which is one of the most unique engineering feats of this century and would leave totally inaccessible a world-renowned and extraordinary natural wonder, Carriso Gorge; and

WHEREAS, the abandonment is contrary to the public interest of the citizens of the City of San Diego and therefore, SD&AE's application must be opposed; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 3. That \$4,000.00 be transferred from the Unallocated Reserve to the Allocated Reserve 100 Fund for the purpose of defraying the expenses incurred in the matter before the Interstate Commerce Commission.
