


RESOLUTION No. 219224

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$11,811.00 by T.G.S. ELECTRIC INC. DBA ARROW ELECTRIC, a corporation, for CONSTRUCTION OF STREET LIGHTING SYSTEMS ON UNIVERSITY AVENUE BETWEEN WINONA AVENUE AND 54TH STREET, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 760362.
2. That the expenditure of \$20,300.00 is hereby authorized out of the Capital Outlay Fund (Fund 245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF STREET LIGHTING SYSTEMS ON UNIVERSITY AVENUE BETWEEN WINONA AVENUE AND 54TH STREET, in the City of San Diego, and related costs.
