That the acceptance by the City Manager of that deed of P AND G INSURANCE COMPANY, a California corporation, as to an undivided 1/3 interest; TERRAL INVESTMENT COMPANY, a California corporation, as to undivided 1/3 interest; and INVESTORS LEASING CORPORATION, a California corporation, as to undivided 1/3 interest, executed in favor of The City of San Diego, bearing date of July 18, 1977, conveying to said City the permanent easement and right of way to construct, reconstruct, maintain, operate and repair a storm drain or drains and a water main or mains affecting a portion of Lot 1, San Diego Center Unit No. 1, according to Map thereof No. 6736 filed in the office of the San Diego County Recorder on September 16, 1970, as more particularly described in said deed, be, and the same is hereby approved.
