

BE IT FURTHER RESOLVED, that expenditure of \$5,000 and \$5,000 is hereby authorized out of Gas Tax Fund 220 and Capital Outlay Fund 245, respectively, of The City of San Diego, solely and exclusively for the purpose of providing funds for the above-referenced services.
