That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with J. H. K. & ASSOCIATES, INC., a California corporation, for professional engineering services for the design of traffic signal and safety lighting systems at the intersections of COLLEGE AVENUE and EL CAJON BOULEVARD, COLLEGE AVENUE and UNIVERSITY AVENUE, 54TH STREET and EL CAJON BOULEVARD and 54TH STREET and UNIVERSITY AVENUE, in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 761031.

BE IT FURTHER RESOLVED, that expenditure of \$8,000 and \$4,000 is hereby authorized out of Gas Tax Fund 220 and Capital Outlay Fund 245, respectively, of The City of San Diego, solely and exclusively for the purpose of providing funds for the above-referenced services.
