(R. 78-314)


Adopted on SEP 7 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of DONALD L. BREN COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date of August 11, 1977, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across all that portion of Parcel 4 of Parcel Map No. 5323, on file in the San Diego County Recorder's Office, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named VILLA NORTE.

That the City Clerk is hereby authorized and empowered to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the San Diego County Recorder.
