VACATION OF A PORTION OF FRONTAGE ROAD, STATE HIGHWAY
RIGHT-OF-WAY RELINQUISHMENT NO. 14734.

WHEREAS, it is proposed that a portion of FRONTAGE ROAD,
State Highway Right-Of-Way Relinquishment No. 14734, be vacated;
and

WHEREAS, the interchange improvements were realigned and
there is no present or prospective use for the street, either
for the public street system for which the right-of-way was
originally acquired or for any other public use of a like nature
that can be anticipated; and

WHEREAS, the public will benefit from the vacation through
improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent
with the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the right-of-
way was originally acquired will not be detrimentally affected
by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
California, that a portion of FRONTAGE ROAD, State Highway
Right-of-Way Relinquishment No. 14734, as more particularly
referred to in Resolution of Intention No. 218986 is
unnecessary for present or prospective public street purposes.



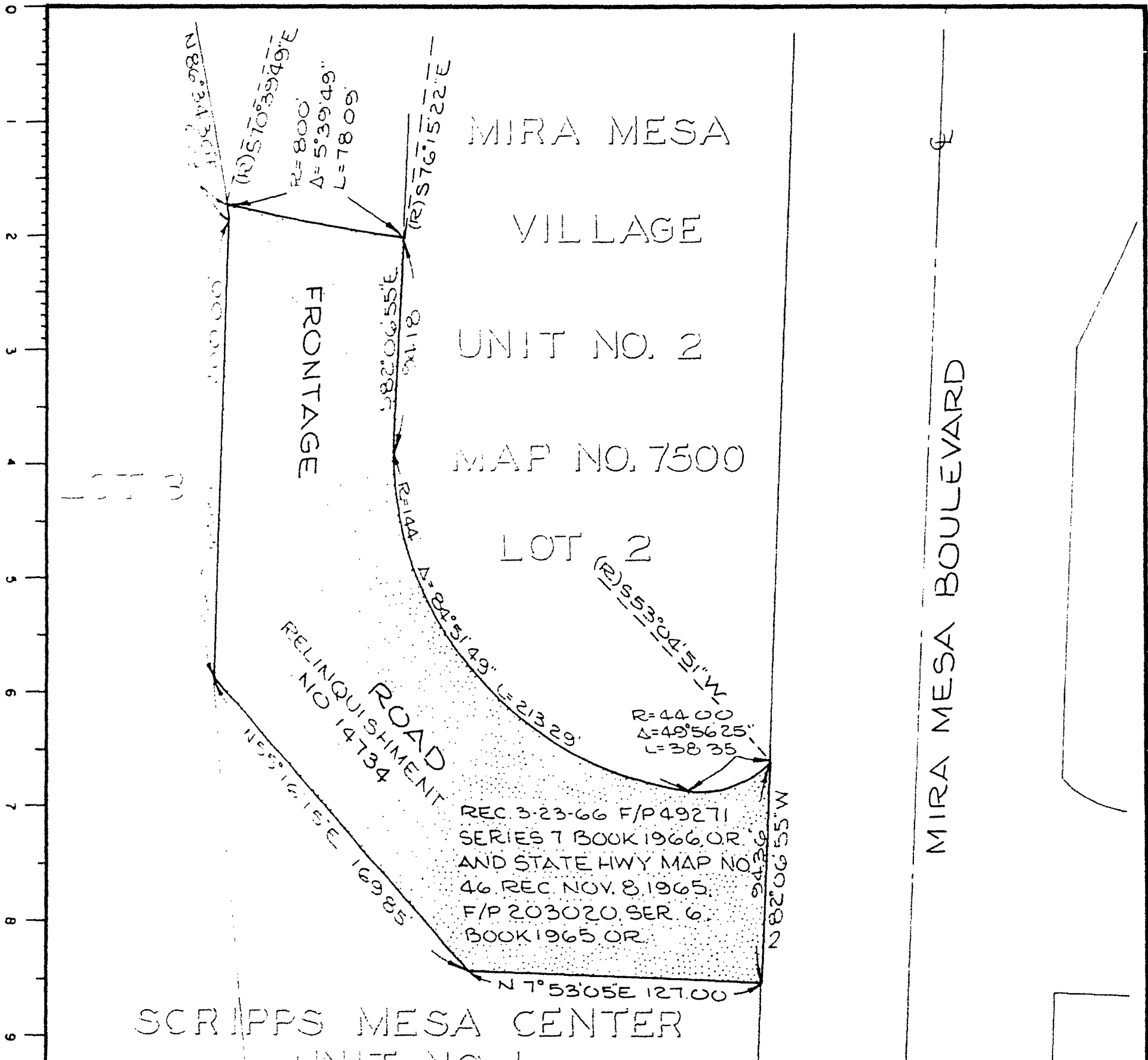

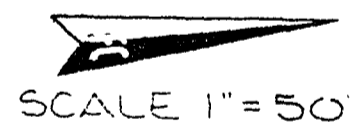
