

WHEREAS, The City of San Diego is the owner of a portion of Section 32, Township 12 South, Range 2 West, SBBM; and

WHEREAS, the herein described property is surplus to City needs; and

WHEREAS, the City desires to negotiate the sale of said property to MARTIN DOUGLAS WILSON and CAROL MAY WILSON, husband and wife, Trustees of the Wilson 1972 Family Trust dated October 23, 1972, all as more particularly described in that form of Grant Deed on file in the office of the City Clerk as Document No. 761021, under the provisions of Section 22.0902 of the San Diego Municipal Code, which permit the sale of real property belonging to the City of San Diego; and

WHEREAS, the sale of this property may reasonably be accomplished only by negotiation because of grade levels and the irregular shape of the property; and

WHEREAS, the value of the property, as determined by an Independent Fee Appraiser, dated January 1, 1977, is the sum of One Hundred Eight Thousand, Eight Hundred Dollars (\$108,800); and

WHEREAS, no real estate broker's commission shall be paid; and

WHEREAS, the sale of the aforementioned property is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That that certain real property described in that form of Grant Deed on file in the office of the City Clerk as Document No. 761021, be and the same is hereby determined to be surplus and is hereby authorized to be sold to MARTIN DOUGLAS WILSON and CAROL MAY WILSON, husband and wife, Trustees of the Wilson 1972 Family Trust dated October 23, 1972, for the sum of One Hundred Eight Thousand, Eight Hundred Dollars (\$108,800).

2. That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, said Grant Deed granting to MARTIN DOUGLAS WILSON and CAROL MAY WILSON, husband and wife, Trustees of the Wilson 1972 Family Trust, all that real property as more particularly described in said form of Grant Deed.

3. That no broker's commission shall be paid by City on the herein described negotiated sale.

4. That Council Policy 700-30 is hereby waived.

5. That the City Clerk is hereby authorized and directed to deliver said Grant Deed and a certified copy of this resolution to the Property Director for further handling.
